I DECLARE THAT:

- 1. I AM UP TO DATE ON RECOMMENDED VACCINES.
- 2. I KNOW AND FOLLOW ALL THE ANTI-COVID RULES.
- 3. I AM NOT IN LOCKDOWN.
- 4. I DO NOT SUFFER FROM COVID-19 SYMPTOMS.
- 5. MY RELATIVES ARE NOT IN LOCKDOWN.
- 6. MY RELATIVES ARE NOT AFFECTED BY COVID-19.
- 7. I DO NOT ATTEND CLASSES IF I AM RUNNING A TEMPERATURE OF 37,5° OR MORE.
- 8. I DO NOT ATTEND CLASSES IN CASE OF SORE THROAT, COLD, CONJUNCTIVITIS, DECREASE/LOSS OF TASTE AND SMELL.
- 9. I SEEK MEDICAL ATTENTION IN CASE OF THE ABOVE-MENTIONED SYMPTOMS (SEE POINTS 7, 8).
- 10. I FOLLOW THE SANITARY RULES: WHEN I AM AT SCHOOL, I USE AN ALCOHOL-BASED HAND RUB AND I REGULARLY AND THOROUGHLY WASH MY HANDS.
- 11. I ALWAYS WEAR A FACE MASK INSIDE THE SCHOOL AND IN THE SCHOOL YARD.
- 12. I RESPECT THE SOCIAL DISTANCING OF AT LEAST 1 METRE FROM THE OTHERS.
- 13. I DO NOT CREATE GATHERINGS.
- 14. IF ABSENT FROM SCHOOL FOR 5 DAYS OR MORE DUE TO ILLNESS, I BRING A MEDICAL CERIFICATE. IF ABSENT FOR OTHER REASONS, I SIGN A SELF-DECLARATION INSTEAD.
- 15. I HAVE RECEIVED THE NECESSARY HYGIENE AND BEHAVIOUR INDICATIONS FROM THE SCHOOL.
- 16. I AM AWARE THAT EVEN IF I RESPECT ALL THE RULES, THE RISK OF CONTAGION IS POSSIBLE.

HOWEVER, BY TAKING THESE SIMPLE PRECAUTIONS, IT IS POSSIBLE TO REDUCE THE CHANCES OF BEING INFECTED OR OF SPREADING COVID-19.
